



UNGP+10 project consultation





Project by the UN Working Group on Business and Human Rights

- Timeline: July 2020 June 2021
- Two main components:

Take stock of first 10 years of the UNGPs (report to Human Rights Council)

Develop a vision and roadmap for global implementation over the next 10 years (launch in June 2021 for UNGPs@10 anniversary)

- Informed by global multistakeholder consultation process
 & collaboration with partners
- Global call for input: see project webpage
